



Infrastructure Resources:

The corporate head office for Tahboub Group is located on Mecca Street, Amman, Jordan and houses all executive, administrative, and support departments along with the MEP Division. Tahboub infrastructure resources include showrooms and workshops. Permanent production facilities are located at the Wadi Al Sir Industrial Area in Amman and at the Amman Airport Qualified Industrial Zone. Permanent and temporary facilities for site offices, workshops, and staff accommodation are also provided.

Tahboub Company for International Supplies expanded its warehousing facilities in the Qastal QIZ and Zarqa Free zone with a total area of 15,000 square meters. Tahboub factories and facilities are specifically equipped for production of hardwood in different species servicing the local market. The Wadi Al Sir Industrial Area premises consist of 5,000 square meters of manufacturing space.

Tahboub Company for Wood Industries' warehousing and factory facilities encompass 20,000 square meters of which 5,000 square meters produce 700 flush doors daily. The kitchen and wardrobe factory facilities include 5,000 square meters equipped with state of the art machinery with a further 5,000 square meters that is used as storage space for raw materials.

Tahboub Automotive houses a 1500 square meter facility in Mecca Street, 6000 square meters facility in Bayader wadi sir and 5000 square meters in Al-Qastal industrial zone.
